WE ARE A GROUP OF ARTISTS, FILMMAKERS, AND CREATIVE HUMANS FROM AROUND THE WORLD, WHOSE LIVES HAVE BEEN TOUCHED BY YOUTH SUICIDE. WE ARE COLLABORATING WITH YOUTH AND MENTAL HEALTH PROFESSIONALS TO CREATE THOUGHTFUL EXPERIENCES AND TOOLS AIMED AT SPARKING THE KIND OF FEARLESS COMMUNICATION THAT CAN SAVE LIVES.
